### **Tax Base / Full Assessed Value**

The Tax Base/Assessed Value represents the total assessed value for the Town. This very important figure is used when determining taxes for businesses and homes. A growing tax base benefits the School District, Town, County and property owners. Since a majority of your tax bill is school taxes, this is the tax where you will realize the largest benefit in relation to the school budget that is approved.

### **Town Population**

The population numbers are reflected in the Census data. The Census is conducted every 10 years. Periodically we will receive Census estimates, which is reflected in the 2016 number. Per the 1990 Census the Town had surpassed 30,000 in population. Our current population is roughly 37,000.

### **Shenendehowa Student Population**

According to the Shen website, Shen has never eclipsed 10,000 students enrolled in the district in a given year. The largest number of enrolled students occurred in 2008 at 9,869. The largest graduating classes occurred in 2015 and 2016 at 779 students. It may surprise you the total enrollment in 2017 was less than the number of enrolled students in 1976.

### **General Fund Property Tax**

Clifton Park enjoys a distinction uncommon with peer municipalities of the same size. The Town does not have a General Fund Property Tax. In NYS, Towns have a General Fund for town operations and a separate Highway Fund for money allocated solely for the operation of the Highway Department. There is also a corresponding tax for each Fund.
