Clifton Park Health Care Investors

Clifton Park Health Care Investors submitted an application for an additional building to be located at and connected to the existing building at the Ellis Hospital campus in Clifton Park. The new building will be 60,000 square feet with an ambulatory surgery center on the first floor. The 2nd floor will contain Ellis owned medical practices. The 3rd floor will contain private practices t6hat will provide services to the ambulatory surgery center. SEQR has been completed and Planning is almost done. It was represented to the Agency that the Town Supervisor is supportive of this project. The applicant is requesting an extended 25 year Pilot. Currently, there are no taxes paid on the land because Ellis Hospital holds title.

A motion was made to schedule a Public Hearing for this project. The motion was seconded and unanimously approved. The hearing is scheduled for December 12, 2018 at 6:30 PM.

MJ Properties/Synergy Park

An application was submitted by this project, seeking sales and mortgage recording tax relief for the infrastructure that needs to be constructed. The Agency will need to take title to the entire park to provide mortgage recording tax relief. As projects are planned, the Agency will deed parcels back.

A motion was made to schedule a Public Hearing for theis project. The motion was seconded and unanimously approved.
